The meeting started at the new time of 5:30pm.

LA started the meeting with a prayer. Governors were then welcomed by JS.

005 19/20 Governing Body Membership

There are three Governor vacancies; 1 for a foundation Governor and 2 for

foundation trustee Governors. PCC hold their next meeting at the end of October

and it is hoped that at this at least one new Governor will be decided.

007 19/20 Minutes of previous meeting

Curriculum Committee - Chair CL

JS talked through the minutes. There was not much to report with actual expenditure

011 19/20 Headteacher's Report

JH talked briefly through the report which had been previously distributed. CP asked who MB was – Mick Betteridge (external advisor and appraisals). JH mentioned that he requires his Performance Management targets to be set. These will be agreed this term.

CP asked who will take the lead at the next SIAMS inspection. This involves a a reasonable amount of preparation and the Governor being in school throughout the inspection. JS and LA agreed to take the lead, with the unanimous support of all Governors.

JH mentioned how he has amended the format of PP reporting. HW suggested having a PP Governor who can prompt questions and challenge in all areas of discussion. Governors thought this an excellent idea. HW volunteered for the role and Governors unanimously agreed.

012 19/20 Summer 2 summative data

JH has received historic data shortly before this meeting, and will report on it at the next meeting, along with relevant more-recent data.

013 19/20 **REHO (Early Help Offer)**

HW will be employed as SENCO from 14/10/19.

014 19/20 Sports Funding and Pupil Premium Sports Funding

JH discussed how much more information is now available publicly and password protect on the school website. It was mentioned that the website was not presently available on mobile phones, but had been and will be again shortly – JH is chasing the issue.

KO's Sports Funding plans have been reviewed by JH, and a new spending plan is to be brought by JH to the next meeting for discussion and approval.

015 19/20 **Policies**

JH mentioned that the new Pay Policy has just been released to schools, and advised that it was accepted without amendment.

In the Playtime policy CL noted the change of time for morning play. Governors discussed recent timing changes including how the start of the school day was amended from playtime to relaxed study. Parent Governors unanimously agreed that it was proving to be a success and SB reported that staff found it a much more productive start.

016 19/20 **Benchmarking**

Governors discussed the advantages and disadvantages in general, and specific differences presented.

017 19/20 School Improvement Plan

JH talked through the new and re-designed SIP mentioning a personalised curriculum to meet the needs of all children. CP asked how staff identified children who were vulnerable to making low progress. JH explained that this was not just PP children, and they are identified through knowing the children and using constant tracking.

CP asked how parents were communicated with. JH explained about 'structured conversations' to create positive working relationships. LA asked if there was anything that could encourage parents who were not as 'on-board' in encouraging their children. JH and HW agreed that this is about knowing the parents and children and treating all as individuals. MT pointed out that some parents (not necessarily our parents) believe that some areas of traditional parenting are now a schools responsibility, and agreed with JH an HW about the need of close and positive working relationships.

JS asked what the SIP could do not just for the lower achieving students, but to stretch and challenge the more able. JH explained that monitoring and differentiation would result in progress for all.

CP asked how the improvement of reading by 10% statement was measured. JH explained in detail about progress measures and year-on-year results.

JHF asked what information will the Governing Body receive about the SIP milestones. JH explained that school data will be presented at Governing Body meetings and will also be available on the school website (public or private area as appropriate).

018 19/20 **SEF**

JH talked through the SEF including hove the SIAMS form is interwoven with general quality assurance. Evidence is provided on quality and evaluation with staff and Governors welcome to comment (the document is on a google drive keeping it dynamic and timely).

JHF asked what the RAG rating was based on. JH explained that presently the boundaries were his views on success and achievement.

019 19/20 **Chairs Report**

Nothing to report.

020 19/20 Extended Services / Explorers

Governors discussed NOR, potential, open days, advertising, the website and social media in relation to making Explorers more successful, self-sufficient and sustainable. CP reported that there is no change in the ongoing poor financial situation. HW asked if a sibling discount might encourage higher attendance. JH reported that parents do not seem to need the service. Governors agreed that having the extended provision attracts families to the school with them seeing it as a safety blanket 'should' they need it.

Governors discussed the chicken and egg situation in that presently it is not financially viable to keep it, but that the school will lose existing and potential families without it.

LA asked for it to be minuted how much the entire Governing Body appreciate the volunteers who manage Explorers.

021 19/20 **Parent View**

There are not currently enough responses to feedback the results.

022 19/20 Governing Body meetings

Governors discussed at length the number, duration and start times of all the meetings (full and committee). It was agreed that some meeting may start at 5:30pm with others at 7:30pm. No decisions were made to change anything else presently.

HW to visit and review once in post. School are monitoring, assessing and updating a provision map.

026 19/20 Safeguarding

JS reported that over the summer a parent was verbally aggressive toward her in a very public place with regard to an internal school circumstance. The parent had assumed that JS knew of and was involved in the situation, possibly even as instigator. JS is concerned that this could happen to another Governor. It is felt that a way to prevent this happening again is to accurately notify all members of the school community what the roles and responsibilities of a Governor are, and are not.

JHF suggested that it is mentioned in an informal way on the next school newsletter, stating that the role is school strategic leadership and not day-to-day activities.

MT asked if JH had completed the Designated Safeguarding Lead training. JH replied not yet though identified that this was an urgent priority.

MT asked if the school is still involved in the High Peak Primary Cluster (yes) and is the executive safeguarding lead still the head at Peak Dale (yes). Governors suggested that JH use this resource as interim support whilst awaiting DSL training. JH agreed and mentioned that an external expert would be highly valuable to the school on an ongoing basis.

JH suggested forging links between the Governing Bodies to share best practice. Governors thought this was an excellent idea.
