

Governing Body

Instrument Of Government

- The name of the school is Taddington and Priestcliffe Church of England Aided Primary School
- The school is a voluntary aided school.
- The name of the governing body is "The governing body of Taddington and Priestcliffe Church of England Aided Primary School".
- The governing body shall consist of:-
 - 2 parent governors.
 - 1 LA governor.
 - 1 staff governor.
 - 1 head teacher.
 - 7 foundation governors
 - Total number of governors is 12.
- The term of office of all governors is 4 years.
- The appointment and removal of foundation governors shall be conducted as follows:
 - The Derby Diocesan Board of Education appoints 4 Foundation governors having regard to (but not being bound by) nominations received from the Taddington Parochial Church Council. As the appointing body and in accordance with Regulation 20(1) of the Regulations, Derby Diocesan Board of Education may remove from office any foundation governor so appointed under paragraph 7(a). For the avoidance of doubt, this right does not extend to the ex-officio foundation governor who shall be appointed and removed in accordance with paragraphs 8 and 9.
 - The trustees of the School charity of Roger Wilkson appoints 2 Foundation governors.
 - o The foundation governor ex-officio shall be appointed as follows:
 - The holder of the following office shall be a foundation governor ex officio the Vicar of Taddington (or his/her successor in title)
 - The Archdeacon of Chesterfield shall be entitled to appoint a substitute foundation governor to act in the place of the ex officio foundation governor whose governorship derives from the office named in (a) above, in the event that that ex officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under Regulation 21(1) of the Regulations. The Archdeacon of Chesterfield may request the removal of the ex-officio Foundation governor and appoint a substitute governor.
- The Trustees of the school are the School Charity of Roger Wilkson.
- Religious ethos of the school: Recognising its historic foundation, the school will preserve its
 religious character in accordance with the principles of the Church of England and in partnership
 with the Church at parish and Diocesan level. The school aims to encourage in the children an
 awareness of God, to teach them about the life of Christ, and to foster love and tolerance in one
 another. It strives to serve its community by providing education of the highest quality within the
 context of Christian belief and practice.
- This Instrument of Government comes into effect on the day of making replacing the Instrument of Government made on 6 April 2004.
- This Instrument was made by order of Derbyshire Local Authority
- A copy of the Instrument of Government must be supplied to every member of the governing body (and the head teacher if not a governor), the school's trustees and to the Diocesan Board of Education.
